With this completion, the next focus will be on rule making regarding accessible prescription labeling.

Director Ortiz covered information regarding the Governor's vaccine mandate. The agency will follow the mandate, which also applies to the Commissioners. The office is still closed and staff are still teleworking.

#### **RECRUITMENT FOR EXECUTIVE DIRECTOR**

Chair Cook and Director Ortiz have been working with the Department of Enterprise Services (DES) to begin the recruitment process. Chair Cook anticipates a workgroup for the hiring process. Director Ortiz had attended a training held by the Equal Employment Opportunity

Commission (EEOC) regarding bias and hiring, and highly recommended it to the Commissioners for this hiring process.

# **COMMISSIONER REPORTING**

Commissioner Mohr is working with the Gonzaga Institute for Hate Studies during their international conference, which will be held from November 4<sup>th</sup> through the 6<sup>th</sup>. He also continues to work with the Spokane Human Rights Task Force on their development for the Hate Report Project.
